

# World Classic and Duals

THE PREQUEL TO THE WORLDS

**APRIL 10 & 11, 2020 • UNION COLLEGE – FIELDHOUSE • SCHENECTADY, NY**

**EVENT PHILOSOPHY:** The World comes to us! That's what has been created. Hot off our Journeyman Fall Classic, one of the preeminent pre-season tournaments in the USA, we've created a freestyle and Greco version for the wrestling community. This is the event that everyone wants to see. It features the best from around the world, squaring off in a round-robin format. We expect competitors from all across the United States of America and several traditional wrestling countries to participate.

**Format:** Eight, twelve or sixteen-man modified round-robin brackets with all decorated and accomplished opponents (four to 5 matches for each wrestler). World, National, State or New England place finishers, followed by state qualifiers.

"Not a world beater", but like freestyle? Don't worry, we pair competitors with like skill levels.

### RULES:

- Cadet/Junior ages combined in the same brackets. 18 years old and younger allowed to participate (Must be in high school, minus international students)
- Athletes cannot wear high school singlets at the competition

### WEIGHTS:

#### Cadet / Junior Division Freestyle:

100 lbs (45.5 kg), 106 lbs (48.2 kg), 113 lbs (51.4 kg), 120 lbs (54.5 kg), 126 lbs (57.3 kg), 132 lb (60 kg), 138 lbs (62.7 kg), 145 lbs (65.9 kg), 152 lbs (69.1 kg), 160 lbs (72.7 kg), 170 lbs (77.2 kg), 182 lbs (82.7 kg), 195 lbs (88.6 kg), 220 lbs (100 kg) and 285 lbs (129.5 kg)

#### Cadet / Junior Division Greco:

106 lbs (48.2 kg), 113 lbs (51.4 kg), 120 lbs (54.5 kg), 126 lbs (57.3 kg), 132 lb (60 kg), 138 lbs (62.7 kg), 145 lbs (65.9 kg), 152 lbs (69.1 kg), 160 lbs (72.7 kg), 170 lbs (77.2 kg), 182 lbs (82.7 kg), 195 lbs (88.6 kg), 220 lbs (100 kg) and 285 lbs (129.5 kg)

\*Cadet / Junior Freestyle and Middle School Freestyle will see international competitors, while Greco is largely domestic.

### REGISTRATION & ENTRY FEE:

All entry forms must be completed online and meet April 5, 2020 deadline or before the event is sold out. Max competitors is 400.

- Once you've received a written pre-approval and a four-digit code from Journeyman Wrestling to wrestle in the event, you'll be directed to register online via [www.journeymenwrestling.com](http://www.journeymenwrestling.com).
- Once you've been approved, you are expected to have finished the registration at that moment (**register and pay**), otherwise the process starts over and eligibility is reassessed. Please reach out only when you're ready to actually enroll.
- **Registration is \$65**
- **THERE ARE ABSOLUTELY NO REFUNDS ONCE YOU REGISTER**
- **Spectator Fee:** \$15 (good for April 11, 2020 only)
- **Spectator Fee:** \$10 (good for April 10, 2020 - DUALS only)
- **Coach's Pass/Fee:** \$35 (good for both days: April 10 & 11, 2020)
- **Spectator Fee:** \$15 (good for April 11 only), Duals \$10 (April 10 only)
- **Coach's Pass/Fee:** \$25 (good for April 11)

### ITINERARY:

#### Weigh ins for Duals: Thursday evening, April 9, 2020

- 6:30-7:30 pm, Union College, Schenectady NY (Fieldhouse). Your team will be assigned a specific weigh-in time.

#### Weigh ins for Individual: Friday evening, April 10, 2020

- 5:30-7:30 pm, Union College, Schenectady NY (Fieldhouse). You will be assigned a specific weigh-in time.

If you weigh-in for the duals, it counts for the individual event on April 11, 2020. Please be advised you will have to make the lower weight as some weights are different between the two events.

**Wrestling begins:** April 10 at 10:00 a.m. **Wrestling begins:** April 11 at 9:30 a.m.

### AWARDS:

Hammers awarded to each "A bracket" winner of the Freestyle division.


MOW hammer awards for GRECO Roman and Middle School division. All bracket winners will receive "Compound" singlets, medals to second and third place finishers.

## USA vs. THE WORLD DUALS • FRIDAY, APRIL 10, 2020

**PHILOSOPHY:** State teams from around the USA will compete against one another, as well as international teams in a dual championship. Ideally 8 - 12 teams will be positioned in a modified round robin bracketing format, producing 3 to 4 matches.

**TIME:** 9:00 AM - 5:00 PM (Estimated).

**LOCATION:** Union College (Field House) Schenectady NY.

**PREREQUISITE:** It is required and understood that competitors participating with teams in the dual portion will also participate in the individual segment held on April 11. The weigh ins from the individual portion carries over to the duals.

**WEIGHTS:** 106, 113, 120, 126, 132, 138, 145, 152, 160, 170, 185, 220 & 285

**ENTRY FEE:** \$550 per team (this fee is separate and distinct from the entry fee required with the individual tournament \$65 per individual).

### PARTICIPANT'S WAIVER AND RELEASE FROM LIABILITY

- I, \_\_\_\_\_, the undersigned, on behalf of myself, my heirs and next of kin, personal representatives, agents, insurers, successors and assigns (all hereinafter "Releasers"), hereby FOREVER RELEASE, DISCHARGE AND COVENANT NOT TO SUE Journeyman Athletics, LLC, its insurers, its affiliated clubs, administrators, agents, directors, officers, state organizations, members, committees, volunteers, all employees of Journeyman Athletics, LLC, and any and all participants, officials, referees, coaches, host clubs, sponsoring agencies, sponsors, advertisers, local organizing committees (and if applicable) owners, lessors and operators of premises used to conduct any Journeyman Athletics, LLC sanctioned events, meet, practice or activity (all hereinafter "Releasees") from any and all liabilities, claims, demands, causes of action or losses of any kind or nature, past, present or future, direct or consequential, that I may hereinafter have for PERSONAL INJURY, PERMANENT, TEMPORARY, TOTAL OR PARTIAL DISABILITY, DISFIGUREMENT, PARALYSIS AND ANY OTHER LOSSES OR DAMAGES TO PERSON OR PROPERTY OR DEATH, arising out of my participation in, attendance at or traveling to and from any Journeyman Athletics, LLC sanctioned event or activity including, but not limited to, LOSSES CAUSED BY THE PASSIVE OR ACTIVE NEGLIGENCE OF THE RELEASEES, or hidden, latent or obvious defects in the facilities or equipment used.
- Releaser understands and acknowledges that Journeyman Athletics, LLC activities and the sport of wrestling in general have inherent dangers that no amount of care, caution, training, instruction, supervision or expertise can eliminate. RELEASOR EXPRESSLY AND VOLUNTARILY ASSUMES ALL RISK OF PERSONAL INJURY, PERMANENT, TEMPORARY, TOTAL OR PARTIAL DISABILITY, DISFIGUREMENT, PARALYSIS AND ANY OTHER LOSSES OR DAMAGES TO PERSON OR PROPERTY OR DEATH, sustained while participating in, attending, preparing for or traveling to and from any Journeyman Athletics, LLC sanctioned event, meet, practice or activity, including the risk of PASSIVE OR ACTIVE NEGLIGENCE OF THE RELEASEES, or hidden, latent or obvious defects in the facilities or equipment used.
- Releaser acknowledges and fully understands that each participant in any Journeyman Athletics, LLC sanction event, meet practice or activity, including Releaser, will be engaging in activities that involve risk of serious injury, including permanent, temporary, total or partial disability, disfigurement, paralysis and any other losses to person or property, including death, and that severe social and economic losses may result not only from Releaser's own actions, inactions or negligence, but also from the actions, inactions or negligence of others notwithstanding the rules of play or the condition of the premises or of any equipment used. Further, Releaser acknowledges and fully understands that there may be other associated risks with such activities which are not known or not reasonably foreseeable at this time.
